19. Evaluation of Milan Conference:

20% respondents; call for papers: 91% agreed that double blind review made for a higher level of Conference; social event could have been better from a catering perspective& excellent for the musical part; length of the Conference, people suggested that 2.5 days was excellent; content of Conference was between -above average and excellent-; Posters were rated above average; overall experience above average. Respondents wanted the call for papers to be more inclusive; organisational committee; community based support rather than hired/ paid staff; people appreciated the keynote speakers; different levels of presentations; workshops space was limited; poster sessions went positively; 80% wanted more workshops; more interactive formats would have been appreciated;

Emerging themes: 'it's not only research that matters' 'innovative technology'. An open space forum, where people will individually present their interest.

- 24. Working Group Report:
 - **State & Mutual Recognition Group:** Imke & Shirley gave some history of what had happened up to the current moment
 - Research Group: Rosemarie Samaritter discovered that there were not available research papers. The group decided to develop connectivity between the various countries. They found a lot of interesting material in MA and PhD thesis. Thought also about where that would go, on website, & accessibility. Focus on building a base, bringing papers into awareness.
 - **Conference Group:** Richard spoke about dialogues held over the year. Ideas for the theme of the Conference in Greece next year.
 - **Communication:** Julia spoke about the communication group being inactive over the last year/ Julia invited people to join the group.
 - Training Standard Group: Vincenzo/Susan spoke about people's contributions over the years. Susan spoke about working to a tight time line. The proposal is a minimum standard and to read as guidelines, and understand that there is a degree of flexibility. 2 special circumstances: The Netherlands (they have a BA training but encouraging students to do MA) and Spain (4 year BA and a 1 year MA). In terms of

MA level, trainings will be proposed at this level. The proposal is that all trainings will be at MA level or the equivalent. There are some variations on the number of European credits. So the entry criteria is BA, experience in a different field, age of entry is 22. Personal Therapy is recommended before beginning the training, however, it is required during the training. Supervision, very important, even in small groups of 2 or 4, minimum strongly recommended a minimum of 100 hours. Susan responded to the feedback: spoke about mentoring and evaluation as fairly new aspects of training. Assessment, more oral assessments, requested. Much dialogue was shared across countries about their standards. Initially it is training standards guidelines.

Title: CROSSING BORDERS AND THE IN-BETWEEN: DMT AT THE LEADING EDGE

As DMTs we are all border-people and we work in liminal spaces, on edges, on borders and with people of all ages and cultures in transition from illness to wellness. The numbers of people crossing inner and outer borders at this time are quite unprecedented, giving many opportunities for us to rise to these new challenges in skilled, embodied and psychotherapeutically informed ways. This exciting conference in the heart of Athens, will address both the inner and outer border crossings that we do in ourselves and with others in the course of our therapeutic work on a variety of themes. It will also offer an opportunity to share and celebrate some of the most innovative and important DMT work going on throughout Europe, at a time of profound change and also opportunity.

Themes

- 1) MIGRATION / REFUGEES DMT as the friend of the stranger (PHILOXENIA), working with trauma, up-rooting, identity-loss, trans-cultural issues in DMT
- CROSSING BORDERS DMTs as border-people, life transitions, ageing & dementia, illness to wellness,
- 3) HAS TECHNOLOGY CHANGED THE FACE AND BODY OF DMT? dealing with space and time in the new era of technology innovative technologies in DMT, training and supervision

Communication group – keeping up communication

Training Standards

- EADMT training standards criteria
- Minimum levels, Full Professional Members should meet these minimum standards by 2020.
- If not MA, it must be equivalent to this level
- Criteria for entry, 2 options.
- a) BA with experience in healthcare setting, and experience with dance.

- b) MA level with 3-5 years of Dance experience. And 1-2 years experience in community.
- Internship, no changes
- Supervision and Personal Therapy expectation remains the same.
- At least a third of movement observation should be Laban based.
- EADMT recognizes that these are valid routes for the Netherlands and Spain
- Rosemarie Samaritter suggested it was difficult to vote on something that she couldn't first ask the national professional body.
- **30. Voting** to adopt the training standard implementations by 2020 21 Votes
- **31.** Dates and hosting confirmation for GA 2019, 2020
 - 2019: Croatia (had already offered in 2016) to host the GA 5th- 6th October 2019 Finland, Israel, Portugal would also consider and offer to host, after checking back with their national assoc.
 - 2020: Conference confirmation in Amsterdam by the end of October, 3rd-4th October 2020; Germany would also consider or offer to host, after checking back with their national assoc.
